#### 1. Course Objective

The objective of the course is to develop students with necessary knowledge and application skills for routine professional problems in the area of law. The course is designed in line with the requirement of HKICPA and provides students with an understanding of the overall legal framework in which businesses in Hong Kong operate. This course will enable students to analyze and apply the relevant laws and principles applicable to business problems.

#### 2. Intended Learning Outcomes

In this course, it will be introduced that the main principles of laws and regulations governing business activities. You will have the basic knowledge to

- 1) analyze the principal concepts of the contract law;
- 2) analyze the principal concepts of the law of tort and negligence;
- 3) analyze the principal concepts of the consumer laws;
- 4) analyze the principal aspects of regulations that govern the different business organizations;
- 5) analyze the principal concepts of the employment laws;
- 6) understand the principal concepts of the bribery and corruption laws;
- 7) understand the principal concepts of the data protection laws.

#### 3. Class Format

In our class, we have lectures, discussions, individual participation, and group participation. In order to get the most out of class sessions, it is important that you actively participate in discussions and exercises.

# 1) Quizzes and final exam

There will be 2 quizzes and 1 final exam during the semester. The scores will constitute 15%, 15%, and 50% of the final grade respectively. The quizzes will consist of short answer questions. All the questions will be based exclusively on class lectures. It should be kept in mind that many topics in the course are interrelated; thus, answering questions relating to a particular topic may require some knowledge of topics discussed earlier.

Quizzes and the final exam will be open-book/open-note tests. They will be held simultaneously for each section. In order to get a convenient time for all students, they have been scheduled in evenings. There will be **NO** new lectures on quiz or exam days.

**No** make up test will be scheduled.

# 2) In-class writing practice

This is a practice of answering legal issues in the legal writing style. This writing practice will not be graded on your writing skills. It will be graded on your understandings of legal principles and legal writing style.

# 3) Assignment

There are 5 assignments after classes and several random mini quizzes during the classes. Late submissions, 50% penalty will be applied.

# 4) Participation

There will be activities during the lectures, such as discussing cases, answering questions, corresponding to other students.

Your participation is suggested to be constructive, positive, and active.
